A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE SOUTHERN PHILIPPINE MEDICAL CENTER (SPMC), THE SURIGAO CITY HEALTH OFFICE (CHO), AND THE HOUSE OF HOPE FOUNDATION FOR KIDS WITH CANCER, INC. (HHFKCI) TO ESTABLISH A COORDINATION AND REFERRAL SYSTEM FOR PEDIATRIC CANCER CASES.

WHEREAS, the Sangguniang Panlungsod is in receipt of an indorsement forwarding the Tripartite Memorandum of Agreement (MOA) between Sounthern Philippines Medical Center (SPMC), Surigao City Health Office (CHO), and House of Hope Foundation for Kids with Cancer, Inc (HHFKCI) for its appropriate action;

WHEREAS, the City Government of Surigao is committed to ensuring accessible, equitable, and quality healthcare services for all its constituents, particularly for children and other vulnerable sectors;

WHEREAS, pediatric cancer requires specialized diagnosis, treatment, and comprehensive support services which are not fully available at the local level, thereby necessitating a structured referral system to tertiary medical institutions;

WHEREAS, the proposed Tripartite Memorandum of Agreement among the Southern Philippine Medical Center, the Surigao City Health Office, and the House of Hope Foundation for Kids with Cancer, Inc. seeks to formalize coordination for the timely referral, treatment, and provision support services for pediatric cancer patients;

WHEREAS, the partnership will strengthen inter-agency collaboration, streamline referral protocols, and improve access to specialized healthcare services for children diagnosed with cancer;




