APPROPRIATION ORDINANCE NO. 03 - 2025

AN ORDINANCE AUTHORIZING THE LOCAL EXPENDITURE PROGRAM (ANNUAL BUDGET) OF SURIGAO CITY IN THE TOTAL AMOUNT OF ONE BILLION SIX-HUNDRED EIGHTY-TWO MILLION THREE HUNDRED FORTY-EIGHT THOUSAND NINETEEN PESOS (PHP 1,682,348.019.00) COVERING GOVERNMENT EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR FISCAL YEAR 2026, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

Be it ordained by the Sangguniang Panlungsod of Surigao City in session assembled, that:

SECTION 1. TITLE - This Ordinance shall be known as the "Appropriation Ordinance for Fiscal Year 2026 of the City Government of Surigao."

SECTION 2. APPROPRIATION OF FUNDS - The total amount of ONE BILLION SIX HUNDRED EIGHTY-TWO MILLION THREE HUNDRED FORTY-EIGHT THOUSAND NINETEEN PESOS (P1,682,348,019.00) is hereby appropriated out of the estimated income of the City Government of Surigao for Fiscal Year 2026, to cover the various expenditures for the operation of the City Government, broken down as follows:

General Fund – P1,663,848,019.00

Economic Enterprises – P18,500,000.00

(Details of specific allocations to departments, offices, and programs shall be incorporated as per the approved Annual Budget Document.)

SECTION 3. USE OF FUNDS - The appropriations authorized under this Ordinance shall be disbursed solely for the purposes indicated in the approved Annual Budget for Fiscal Year 2026, subject to existing budgeting, accounting, and auditing rules and regulations.

SECTION 4. IMPLEMENTING AUTHORITY - The City Mayor is hereby authorized to implement this Ordinance and to approve the corresponding disbursements in accordance with applicable laws, rules, and regulations.


SECTION 5. SEPARABILITY CLAUSE - If any part or provision of this Ordinance is declared invalid or unconstitutional, the remaining portions not affected thereby shall remain in full force and effect.


SECTION 6. EFFECTIVITY - This Ordinance shall take effect on January 1, 2026.


