Limcangco as Pathologist of the City Health Office effective January 1, 2024 to December 2024.*

The Committee is in receipt of an indorsement from the...this should be City Health Office, requesting for the renewal of the appointment of Dr. Ponciano S. Limcangco as Pathologist of the City Health Office, with an honorarium of Five Thousand Pesos (P5,000.00) per month, effective January 1, 2024 to December 2024. The said appointment is in compliance to the requirement of the Department of Health and PHILHEALTH for the issuance of License to Operate the Surigao City Health Clinical Laboratory. This however, upon reviewal of the draft MOA forwarded to the committee, the signatory of the MOA representing the LGU is Dr. Benjielita P. Notada, City Health Officer II of the City Health Office. This should be amended and the signatory of the MOA should be the Chief Executive Officer of the LGU.
