Proposed Ordinance, "An Ordinance Amending Ordinance No. 351, Series of 2012, An Ordinance Establishing the Night Market at the Surigao City Boulevard, Lopez Jaena, and Borromeo corner Magallanes up to the corner of Parrucho Street of the City of Surigao, Providing Guidelines Therefor and For Other Purposes." (By: Committee on Trade, Business, Industry and Economic Enterprise)

Honorable Abian was recognized.

#### HON. BALTAZAR C. ABIAN:

Mr. Chair, again, marajaw na hapon. This is for the Second Reading, after having our 3<sup>rd</sup> Committee Hearing on the Proposed Ordinance Establishing the Night Market at the Surigao City Boulevard, Lopez Jaena, and Borromeo corner Magallanes up to the corner of Parrucho Street of the City of Surigao, Providing Guidelines Therefor and For Other Purposes.

A proposed ordinance was submitted to the Committee on Trade, Business, Industry and Economic Enterprise, amending Ordinance No. 351, Series of 2012. In the said proposed ordinance, Lopez Jaena, and Borromeo corner Magallanes up to the corner of Parrucho Streets were added as additional venues to the Night Market guidelines of the operation of the Night Market were also set in place.

During the 24<sup>th</sup> Regular Session, this honourable court referred this matter back to the committee to discuss on the following matters:

1. Changing the initial proposed start time of operation at the City Boulevard Night Market from 7pm to 6pm, and proper traffic implementation in the Night Market Area.

After thorough review, this committee concludes that changing the start time of operations at City boulevard from 7:00pm to 6:00pm is feasible with the dedicated support and strict enforcement of traffic rules by the City Traffic and Management Office, the concerned barangay, and the police. This adjustment is anticipated to benefit the registered vendors at the night market, as foot traffic peaks during dinner time and begins to diminish around 8:00pm.

The committee also finds that:

A. Traffic would be more organized if both lanes of Lopez Jaena Street remain open to traffic and that only one lane should be closed from Borromeo Corner Magallanes to the corner of Parrucho Street (Baybay Magallanes). Additionally, the open lanes of Baybay Magallanes and Lopez Jaena should be designated as strictly as NO PARKING ZONES, and

B. Implementing a fine of five hundred pesos (P500.00) for the first offense and one thousand pesos (P1,000.00) for the second offense for ambulant vending of goods or consumables, whether similar or not to those being sold inside the designated night market area, on any other street or sidewalk within the designated area.

The Committee on Trade, Business, Industry and Economic Enterprise recommends the passage of the proposed amended ordinance establishing the night market at the Surigao City Boulevard, Lopez Jaena, and Borromeo Corner Magallanes up to the Corner of Parrucho Street of the City of Surigao, providing guidelines therefor and for other purposes.

I so move for the approval on second reading, Mr. Chair.

The motion was approved. During discussion, the **RULES ARE SUSPENDED** to allow the resource persons to join the discussion.

#### ATTY. DAHLIA CLAUDINE MAY B. FERRAL / BPLO HEAD:

Good afternoon, Mr. Hon. Chair and the members of this council. One of the changes suggested during the last regular session was that, the start time of the operations at the City Boulevard be changed from 7:00 o 'clock in the evening to 12:00 midnight to 6:00 o 'clock in the evening to 12:00 midnight. And then the other changes suggested here, for the traffic implementation is that, it was changed from closing both lanes at the Lopez Jaena Street, it was now suggested by the members of the committee that both lanes will be now open to traffic at Lopez Jaena and then only one lane shall be strictly close during the operation of the night market at Baybay Magallanes from Mondays to Sundays from 5:00pm to 10:00pm. And then adding also that the street or the open streets at Baybay Magallanes and Lopez Jaena Street will be considered as strictly a NO PARKING ZONE and the parked vehicles here will be towed by the City Traffic and Management Office.

Other than that, the under Section 8, the definition for ambulant vendors was also added including a change in the prohibition from ambulant vending of goods or consumables before it was only included that it was only similar to those being sold inside the designated night market. However, it was recommended by the committee that it be added that "whether similar or not to those being sold inside the designated Surigao City night market be strictly prohibited to be sold in the area".

 And lastly, it was also added for the first and second offenses, the fines of P500.00 and P1,000 for the second offense. For those who are ambulant vending of goods or consumables whether similar or not to those being sold inside the designated market night area or on any other streets or sidewalk within the designated area. Those are the only changes suggested from the last regular session, Mr. Chair.

The traffic route and parking areas for the Night Market was thoroughly discussed. It was also proposed to reduce the fees for the operation of Night Market.

#### HON. JOSHUA EMILIO S. GELI:

Ah Mr. Chairman, I suggested we integrate that ₱100.00 to the special business permit kay dayan raba ini.

 Are you suggesting that they can use the space owned by the city for free? Because it may set a very bad precedent. What if the next set of vendors will apply and petition the government to open more night markets? That's just my opinion Mr. Chairman.

#### HON. JOSE EXPEDITUS B. BAYANA:

₱100.00 a day times 30 days, that would be 3,000.00 a month. Or ,e-lower ato na jaon ila special permit fee.
