HON. KARL DUANE A. CASURRA:

We received a copy from the City Mayor's Office denominated the as Urgent requesting the City Council to pass a Resolution amending SP Resolution No. 227 – 2024. A Resolution authorizing the City Mayor, Pablo Yves L. Dumlao, II to enter into a Memorandum of Agreement with the Department of Education, Surigao City Division for the establishment of a New Secondary School in Barangay Luna, and that the name of the proposed school is Doña Rosario Diez Cortes National High School in honor of the matriarch of the donor.

And as we may recall, the Sangguniang Panlungsod through SP Resolution No. 227-2024. A resolution authorizing the City Mayor Pablo Yves Dumlao II, to enter into a Memorandum of Agreement with the Department of Education, Surigao City Division, for the establishment of a new Secondary School in Barangay Luna, a parcel of land donated by the I.R. Cortes Realty Development Corporation located at the Barangay Luna to the Department of Education, Surigao City Division, for the establishment of a National High School, and that the existing SP Resolution No. 227 Series of 2024 did not indicate the name of the School. Thus, the Department of Education, Surigao City Division, has requested that the name of the proposed School, Doña Rosario Diez Cortes National High School, be explicitly stated in the title of the resolution as required by the Department of Education Central Office in order for it to proceed. With this urgent request, I proposed for the amendment of SP Resolution No. 227-2024 to include in the title of the resolution the name of the proposed School, Doña Rosario Diez Cortes National High School, and will read as follows:

“A resolution amending Resolution No. 227-2024, a Resolution authorizing the Honorable City Mayor Pablo Yves L. Dumlao II, to enter into a Memorandum of Agreement with the Department of Education, Surigao City Division, for the establishment of a new Secondary School in Barangay Luna to be named as Doña Rosario Diez Cortes National High School.”

I urge my esteemed colleagues to support this Resolution. And I...

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

You make the proper motion. This is just simply an amendment because we already have approved this Resolution, only that the Department of Education would like to indicate the name of the School from Barangay Luna National High School to Doña Rosario Diez Cortes National High School. So, what is needed is just only the amendment...

Honorable Casurra presented a motion which was favorably seconded and approved, to wit:

RESOLUTION NO. 312 - 2024

A RESOLUTION AMENDING SP RESOLUTION NO. 227-2024 TO REFLECT THE NAME OF THE PROPOSED SCHOOL AS DOÑA ROSARIO DIEZ CORTES NATIONAL HIGH SCHOOL.

WHEREAS, the Sangguniang Panlungsod was in receipt of an indorsement from the City Mayor, denominated as URGENT, regarding the request of the Department of Education-Surigao City to amend SP Resolution No. 227, Series of 2024, entitled: “A Resolution Authorizing the City Mayor Pablo Yves L. Dumlao II to Enter into a Memorandum of Agreement (MOA) with the Department of Education- Surigao City for the Establishment of a New Secondary School in Barangay Luna.”, to explicitly state the name of the proposed school as Doña Rosario Diez Cortes National High School, for immediate favorable action and approval;

WHEREAS, SP Resolution No. 227-2024, titled “A resolution authorizing the Honorable City Mayor Pablo Yves L. Dumlao II To Enter Into A Memorandum Of Agreement With The Department Of Education-Surigao City For The Establishment Of A New Secondary School In Barangay Luna”, does not specify the name of the proposed school;

WHEREAS, the Department of Education-Surigao City Division has clarified that the name of the school should be explicitly stated as Doña Rosario Diez Cortes National High School, as required by the Department of Education Central Office;

WHEREAS, there is a need to amend SP Resolution No. 227-2024 to reflect the correct and complete name of the proposed school to ensure compliance with the requirements of the Department of Education Central Office;

HON. JOSHUA EMILIO S. GELI:

Thank you, Mr. Chairman. Honorable Bayana was recognized.

HON. JOSE EXPEDITUSE B. BAYANA:

This is with reference to referral no. 4, I'm referring to Referral to Committees, a resolution showing the unfavorable financial status of the Local Government Unit of Surigao City on the operation of its city public market. May we request the secretariat to furnish us copies of the Amended Contract of Lease because we have no copies of the same, and to invite representative of the Primark so and so, when the resolution will be taken up in the plenary by the Committee on Rules, Mr. Chairman.

Copies of the Amended Lease Agreement of Philippine Primark Properties, Incorporated and the Local Government Unit of Surigao for the construction of the Surigao City Public Market were distributed to each member of the city council.

HON. JOSE EXPEDITUSE B. BAYANA:

Or would it be preferable if I would pass a resolution, Mr. Chairman, requesting for the invitation of the representative of Primark.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

We still...

HON. JOSE EXPEDITUSE B. BAYANA:

Or, would that...

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

After the Committee on Rules, probably, because I do not know if we will treat this today? This was just indorsed only to...

HON. JOSE EXPEDITUSE B. BAYANA:

Today, today, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Today. I do not know how you will treat this Councilor Catre?

HON. NOEL CHRISTIAN G. CATRE, JR.:

Well, to set the record straight Mr. Chairman, I was against this contract with the Primark, so I intend to pass a resolution actually, declaring that the Amended Lease Agreement is unfavorable to the City Government of Surigao.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Are you now ready to pass that resolution?

HON. NOEL CHRISTIAN G. CATRE, JR.:

Yes, Mr. Chairman.

HON. JOSE EXPEDITUSE B. BAYANA:

Can we take that up in the next session, and then we can invite the representative of the Primark? For the record also, Mr. Chairman, we have not taken, I personally, have not taken a stand on the matter.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Yes. That's why, it's now the call of the Chair, Committee on Rules, what to do with the indorsement because we just have indorsed this legal opinion of the City Legal Officer with respect to the so called unfavorable financial status of the Local Government Unit in the operation of its City Public Market. My worry here is that this is simply an indorsement of the legal opinion, there is nothing that would indicate that there is a proposed motion or proposal for termination of the Lease Agreement.

HON. NOEL CHRISTIAN G. CATRE, JR.:

Exactly, Mr. Chairman, I will only move to declare a resolution or a mere sentiment actually, Mr. Chairman, that this contract with the Primark...

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Can we just hold on to that until such time that we will conduct a thorough review of the legal opinion, so that we will also have basis for the members of this council to state their position on the matter.

HON. NOEL CHRISTIAN G. CATRE, JR.:

Of course, I will yield to the wisdom of the....

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

If you really have to read, it's not, the indorsement is just only, it is a legal opinion on the what? The Local Finance Committee Resolution No. 82. What is Resolution No. 82, Series of 2024? It is simply a resolution showing unfavorable financial status, there is nothing that would indicate that there is a proposal that would to terminate the Amended Lease Agreement, otherwise, they could have it stated that the...we will just try to have it that the, that the process will also not be...

HON. CACEL R. AZARCON:

Mr. Chairman...

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Given the...we have always that so called due process, anyway.

HON. CACEL R. AZARCON:

Mr. Chairman, please...

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Yes, Councilor Azarcon.

HON. CACEL R. AZARCON:

If we will read that indorsement, there is nothing that the indorsement, there is no such, it is not asking for something for the Sangguniang Panlungsod, it was merely indorsed. And for what? We do not know what we are going to do with that indorsement. And second is that, I think it would

be prudent if we will be given enough time to re-evaluate the amended contract, Amended Lease Agreement, so that we will be able to find and see if there are really violations committed by Primark. So that we can use those grounds for possible rescission or termination of the contract. We will be guided and we will review the amended contract, Mr. Chairman. As of now, me personally, I don't have yet, I have to come up yet with my own position...

But upon looking up at legal opinion of the City Legal Officer, I think I do believe on him, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

We will just take note of the manifestation of Councilor Catre that as of now it is on that we are leading to that but considering that there is nothing that would indicate in the indorsement for the termination of the Amended Lease Agreement let us just have it that we will have to discuss this for each member of this Council to be given the opportunity to share their thoughts also and making sure that we will have a very, very strong stand on the issue of the possible termination of the Amended Lease Agreement. Is that alright with you, Councilor Catre? We will just take note of your stand...

HON. NOEL CHRISTIAN G. CATRE, JR.:

Yes, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

That you as early as today, you are now coming up with the proposal to terminate the Amended Lease Agreement.

HON. NOEL CHRISTIAN G. CATRE, JR.:

Yes, Mr. Chairman. I am for the rescission of the contract of Primark.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Can we have it on Tuesday, that we can have a committee hearing on that?

HON. NOEL CHRISTIAN G. CATRE, JR.:

December 24?

HON. JOSE EXPEDITUS B. BAYANA:

Can we have it on January, Mr. Chairman?

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Okay, January. So, we will have it on January, the first week of January and making sure that, anyway it has already sounded off that upon the receipt of this indorsement the Chair Committee on Rules had already expressed his intention to file a resolution that would terminate/rescind the Amended Lease Agreement although the sentiment of this council is for us to be able discuss first the issue at hand so that each and every member of this Council be given a chance to have his or her position on the matter.

HON. CACEL R. AZARCON:

One more Mr. Chairman, I think this is only my suggestion for transparency and for, of course for observance of due process. It is my suggestion, Mr. Chairman, that we will invite Primark.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Yes.

HON. CACEL R. AZARCON:

So that we can ask from them the reason why because under number two of the legal opinion states that despite effort the lease agreement has not yet been implemented. What are they reasons why it has not been implemented? So, we need representative from Primark once this matter taken, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

We'll taken, Councilor Azarcon. So, we will just hold on to it at this point in time because of we do not have luxury of time to entertain this because of the holiday break and we will just have this, considered as priority in our succeeding regular session. I personally would like also to have this taken in a way that we have a strong stand not just really but we take the legal opinion hook, line and sinker because there are legal implications as pointed out by Councilor Catre he is now really in the position to terminate the lease agreement. So, termination really is something that will end the Lease Agreement but for our purposes and being members of this council we are to be given the chance also hear our side on this matter. We are already being given the que that this financial status of the Local Government Unit of Surigao has really been not favorable.

So, we will have, the Secretary is hereby directed to make available and write a letter in view of this development after our initial discussion on this as an urgent matter that we will have to treat next year, January. Any other matters?

HON. JOSE EXPEDITUS B. BAYANA:

Yes, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Councilor Bayana is recognized.

HON. JOSE EXPEDITUS B. BAYANA:

One last thing, Mr. Chairman. We have been informed, Mr. Chairman that the additional wages for the job order employees of the Sangguniang Panlungsod will be handed out on December 23?

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

There is a memorandum that was issued, I just read it this afternoon.

HON. JOSE EXPEDITUS B. BAYANA:

That is why, December 23 might be too close, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

We will request that the SP will be spared on this and probably the last could be...because that is our funds, I mean, we should be guided also by way of our thinking that these are funds of the Sangguniang Panlungsod. Anyway, we'll just try to see.

HON. JOSE EXPEDITUS B. BAYANA:

We can just pass a resolution to that effect, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

Yes, you can if the members of this Council but that would be inappropriate at this point in time because I will have to make representation. Ako nalang, I will just be the one to make a representation.

HON. JOSE EXPEDITUS B. BAYANA:

Okay, we will give to you, Mr. Chairman.

HON. ALFONSO S. CASURRA/PRESIDING OFFICER:

To exempt from the Memorandum, the Sangguniang Panlungsod.

HON. JOSE EXPEDITUS B. BAYANA:

That would be all, Mr. Chairman. So, your word is enough for us.

ADJOURNMENT

There being no other matters discussed, the 50th Regular Session was adjourned at 2:50 o'clock in the afternoon of December 19, 2024.
