1. CALENDAR OF BUSINESS

 Indorsement from the City Mayor, denominated as Urgent, letter of Atty. Jeffrey P. Galido, City Budget Officer, requesting for Supplemental Budget No.01, CY 2025 in the amount of Sixty-Five Million Pesos (P65,000,000.00).

HON. JOENIL B. ALDONZA:

Good afternoon, Mr. Chairman, and to the honorable body. Mr. Chairman, since this indorsement from the City Mayor denominated as urgent, may I request, Mr. Chairman for the suspension of the rules.

HON, ALFONSO S. CASURRA / PRESIDING OFFICER:

Yes, before that we will just try to consider that this session today is being converted into a Committee as a Whole for purposes of discussion as urgent, the Supplemental Budget No.1, 65,000,000.00, in the amount of P65,000,000.00. The rules are suspended to allow City Budget Officer, Galido and his twin brother, the City Treasurer. You can now go ahead, Councilor Aldonza.

Councilor Joenil B. Aldonza moved for the suspension of the rules to accommodate Atty. Jeffrey P. Galido, City Budget Officer, and Mr. Alcala, the City Treasurer, to give an explanation of what the request is all about. The **RULES ARE SUSPENDED**.

The City Budget Officer, Atty. Jeffrey P. Galido announced that the primary purpose of the supplemental budget is to adopt the second-class municipality, first tranche. This is in accordance with the DBM circular, which requires salary adjustments from third-class city to second-class city. And the payment of the city accountant's salary, which is partially accommodated due to limited surplus. The supplemental budget of 65,000,000.00 was allocated to three major classifications: salary adjustment for the city accountant's salary, salary adjustment to adopt a second-class city, and other unfulfilled projects of the city.

Differentials will be retroacted in January due to being classified as a second-class city.

Furthermore, the Hon. Cacel R. Azarcon asked for clarification regarding the purchase of one-unit amphibious excavator.

HON. CACEL R. AZARCON:

What about this purchase of one-unit amphibious excavator for the City General Service Office?

ATTY. JEFFREY P. GALIDO / CITY BUDGET OFFICER:

That item is taken from the realigned unutilized 5% utilization, your Honor, which is one of the heavy equipment needed by the city in the previous AIP, which is not budgeted because of our limited annual income, your Honor.
